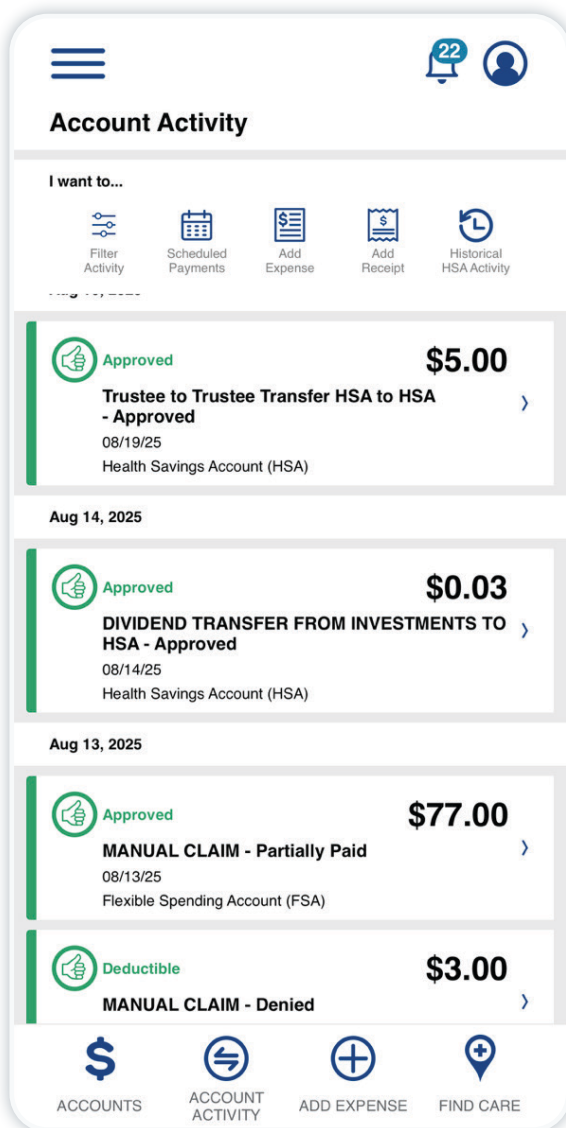

- Select security questions, then verify your name and email to complete registration.

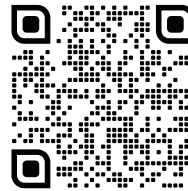
