2. Criteria for rehiring a retired employee						
 I am returning to a regular position (non-elected/appointed) Please check acknowledgment of all below: Employee must have a <i>bona fide separation</i> before returning to work per IRS rules, meaning no formal or informal agreement has been made to return to work prior to retirement. Employee must have 60 days of separation since effective termination date (last day worked). If separation of employment does not meet the criteria above, retirement payment will be immediately suspended until employment is ended. Employee may incur significant tax penalties and/or need to repay associated retirement benefits. Employee may work up to 1,000 hours** in a calendar year before their pension will be suspended (until employment has ended). Employee understands that if the reported hours exceed the hour limitation, they will be required to repay associated retirement benefits accrued after 1,000 hours** and may incur tax penalties. ** 1,000 hour limit rule does not apply for returning Defined Contribution employees and is suspended through 12/31/2027 for all returning employees 	 Employee must have a <i>bona fide separation</i> before returning to work, per IRS rules, meaning no formal or informal agreement has been made to return to work prior to retirement. If re-elected/appointed into the same position, employee must have 2 years of separation. If elected/appointed into a different position, employee must have 60 days of separation. If any of the above criteria are not met, retirement payments will be suspended until employment is ended. Employee will be required to repay any retirement payments received and may incur significant tax penalties.
